TERMS & CONDITIONS / LIABILITY RELEASE

Thank you for your interest in participating in *Armed Forces, Military Veterans & First Responders Appreciation Day*, we hope that you have an enjoyable experience. Please review the terms and conditions shown below.

SET UP/TEAR DOWN/HOURS OF OPERATION

Vendor spaces will be approved upon receipt of payment in full with required documentation. All vendors may set up on Friday, October 18th from at 5 PM to 8 PM. **Vendors are required to be open for the duration of the event, Saturday, October 19, 10:30 am – 4:00 PM. No tear down is allowed prior to close of event.** Closing early or preparing to close may appear as though the event is closed for the evening, and event patrons may choose to leave early which can hurt the success of our vendors. Vendors must have property and debris removed from premises no later than 5:30 PM.

FEES/CANCELLATIONS

Full payment must accompany the signed application. THERE IS NO REFUND OR FEE TRANSFER FOR “NO-SHOWS.”

SPACE SPECIFICATIONS

All space assignments are made at the discretion of the Event. *****All spaces are 10' x 10' covered tent, 8 ft. table & 2 chairs.** If you have displays, equipment, or products that cannot fit into the confines of this space, you will need to purchase and/or will be charged for additional space(s). Layouts are predetermined with the legal requirements for fire lanes and the safety of our visitors in mind. You will not be able to park your vehicle in or near your vendor space. Designated vendor parking spaces will be provided. You may not camp overnight in your vendor space. No controversial booths will be accepted into the show, the goal of quality, diversity, variety, and limited duplication of products and services.

FOOD/BEVERAGE VENDING
